This is a funeral where family and friends have a ceremony, event or service for the deceased person at the same time as they attend their burial or cremation.	
• Taking care of all necessary legal and administrative arrangements.	£895.00
• Collecting and transporting the deceased person from the place of death (normally within 15 miles of the funeral director's premises) into the funeral director's care.	£220.00
• Care of the deceased person before the funeral in appropriate facilities. The deceased person will be kept at the funeral director's branch premises.	£250.00

• Viewing of the deceased person for family and friends by appointment with the funeral director (where viewing is requested by the customer).	£30.00

<b>UNATTENDED FUNERAL</b>	
This is a funeral where family and friends may choose to have a ceremony, event or service for the deceased person, but they do not attend the burial or cremation itself.

<sup>1</sup> This fee (which is sometimes called the interment fee) is the charge made for digging and closing a new grave, or for reopening and closing an existing grave.

<sup>2</sup> In England, Wales and Northern Ireland you will usually need to pay doctors' fees as well. This is the charge for two doctors to sign the Medical Certificates for Cremation.

## Terms of Business

### **1. CMA Unattended Funerals from the Standardised Price List**

Payment is required in full for **CMA Unattended Funerals** within 5 working days of making the arrangements.

### **2. CMA Attended Funerals from the Standardised Price List**

A deposit is required for all **CMA Attended Funerals**, the deposit normally being the known third party disbursements paid on your behalf as indicated on the written estimate. This will be required within 5 working days of making the arrangements. G.T. Edwards reserves the right to request a larger deposit or even payment in full in advance. The final statement indicating the balance will be posted approximately 7 days after the funeral has taken place. **The account must be settled in full within 30 days of the final statement** unless prior arrangements have been made for repayments.

### **3. Tailor made Funeral Services from the Additional Options Price List**

A deposit is required for all **Tailor made Funeral Services from the Additional Options Price List**, the deposit normally being the known third party disbursements paid on your behalf as indicated on the written estimate. This will be required within 5 working days of making the arrangements. G.T. Edwards reserves the right to request a larger deposit or even payment in full in advance. The final statement indicating the balance will be posted approximately 7 days after the funeral has taken place. **The account must be settled in full within 60 days of the final statement** unless prior arrangements have been made for repayments. Where applicable, a £100 discount will be granted for prompt payment in full of the balance for the funeral within 30 days of receipt of the final account.

## Payment Terms

We accept payment by cheque, cash, bank transfer, credit and debit cards.

G.T. Edwards reserves the right to engage a third party to recover unpaid accounts to which all court and legal fees and any other associated costs incurred in its recovery shall be added.

Attended Service direct to graveside or crematorium

1. Taking care of the necessary legal and administrative arrangements.
2. Collecting and transporting the deceased person from the place of death (normally within 15 miles of the Funeral Director's premises) into the Funeral Director's care.
3. Care of the deceased person before the funeral in appropriate facilities.
4. Providing a suitable coffin.
5. Viewing of the deceased person for family and friends, by appointment with the Funeral Director.
6. Provision of a hearse or other appropriate vehicle to take the deceased person to the agreed cemetery or crematorium (normally within 20 miles of the Funeral Director's premises) at a date and time agreed between the Customer and Funeral Director.
